### **General Guidelines for All Inspections**

\* Permit from Fire Department

\* 4 inch contrasting color numbers on house - visible from street or signage is in place for businesses.

\* Carbon Monoxide Detectors are less than 7 years old

\* Smoke Detectors are in the correct locations and work when tested and less than 10 years old.

\* Carbon Monoxide Detectors are in correct

locations (each level and within 10 ft of bedrooms) and work when tested.

\$50.00

### **Multi Family Smoke /CO - Sale or transfer**

\$50.00

### **New Construction / Plan Review / Rough Wiring Inspections - NO FEE**
